95 KGGO'S "ANCIENT ALIENS TEXT" CONTEST OFFICIAL RULES

The Station will conduct the **95 KGGO'S "ANCIENT ALIENS TEXT"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. - 2. Contest Period. The Contest entry period will begin at 5:30 PM CT on Friday, April 25, 2025 and will run from 5:30 PM CT until 11:59 PM CT on Sunday, April 27, 2025 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. How to Enter.
- 4. Text: Listen to the Station during the Contest Period. When the Station announces the Contest keyword, entrant must send a text message with the keyword spelled correctly to 515-809-9595 during the Contest Period. All entries must be received by 11:59 PM CT on April 27, 2025 to be eligible for a chance to win a prize. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider. Limit one (1) entry per person per phone number.
- 5. Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. permitted to rescind their acceptance of the prize and/or return the prize.
